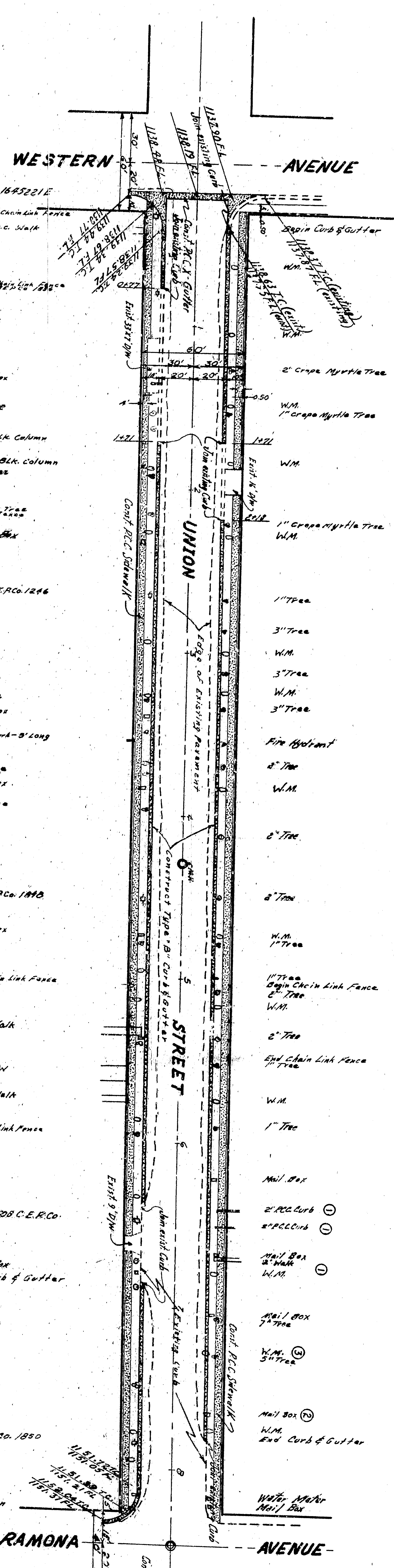

GENERAL NOTES

1. All work embodied on this plan shall be done in conformity with applicable provisions of Standard Specifications No. 271 and Standard Drawing No. 23-21 on file in the Office of the City Engineer.
2. Reveal curbs for driveways where necessary. Exact location and width to be determined in the field. Widths not to exceed city standards.
3. Payment for all removal, earthwork, watering and adjusting sewer manholes, grades shall be included. In price paid for labor, contract items and no additional compensation will be allowed therefor.
4. Obstructions, markings on plans as directed by Engineer.
  - ⓐ To be removed under this contract.
  - ⓑ To be removed and replaced under this contract (footings on street signs shall be class "B" concrete, same as original install.)
  - ⓒ To be removed and replaced by others.
  - ⓓ To be removed and deposited on adjacent property.
