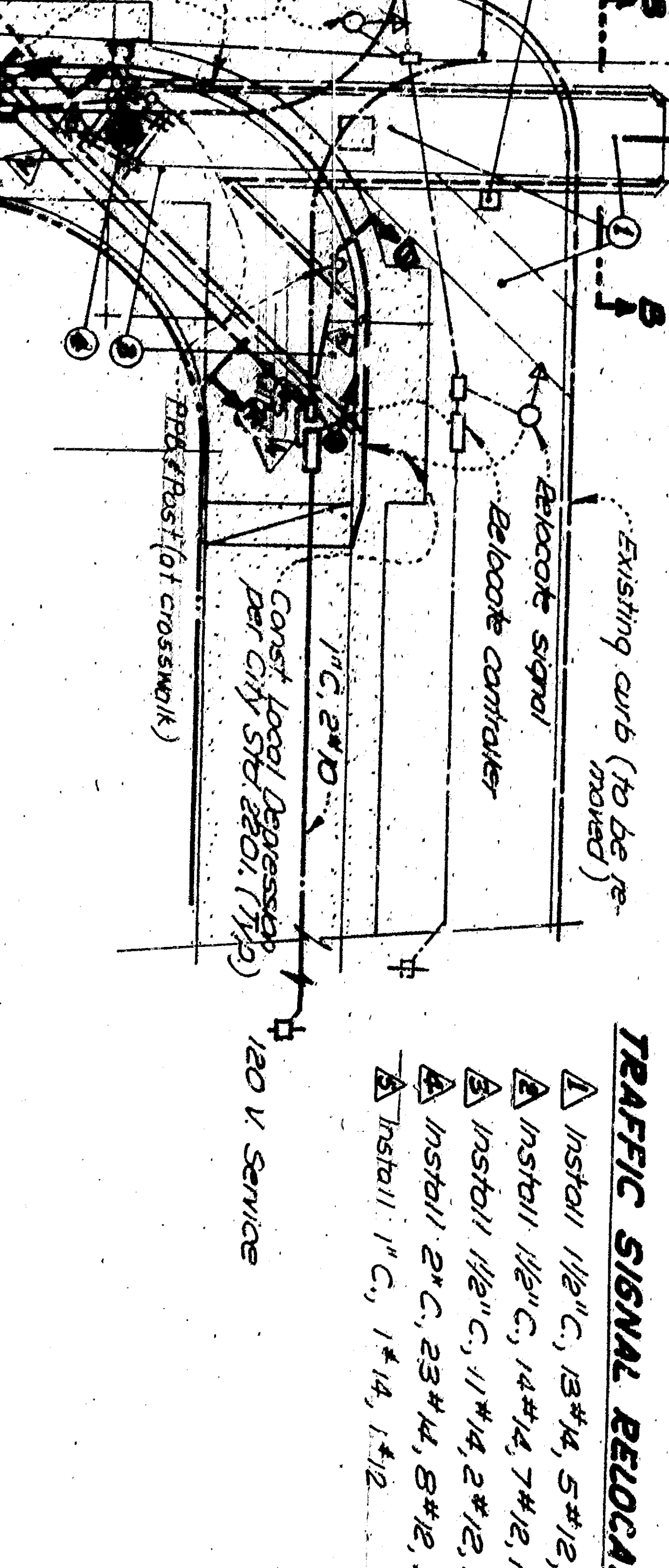


- CONSTRUCTION NOTES**
